1.Product name / description:

SOOTBREAKER GS boiler cleaning liquid

2. Composition / information on ingredients: Blend of alkaline earth oxidising agents and catalysts. Potassium and sodium nitrates < 19%.

3. Hazards identification:

Oxidising agent in aqueous solution.

4. FIRST AID MEASURES:

<u>Eves</u>: Irrigate thoroughly with water for at least 10 minutes. <u>Skin</u>: Wash with soap and plenty of water. <u>Ingestion</u>: Wash out mouth with water, and give water to drink. **DO NOT INDUCE VOMITING**. If patient feels unwell seek medical attention. <u>Inhalation</u>: n/a.

5. Fire fighting measures:
